



Supply Chain Synergy















- May 2019: Implemented TABS booking by block changes and dynamic appointment allocation
 - Resulted in 20% more slots
 - Improved truck turn time (gate-in to last execution)
- Crane productivity recovery
 - Implemented enhancements through efficient use of our TOS N4 system
 - This helped us balance vessel and gate priorities better; yard utilization dropped as a result

2019 EFFICIENCY IMPROVEMENTS



- Continuous removal and/or relocation of long-term overstaying containers
- Engagement with both the PPA and LGU for Access Road improvements and better links to the outside road network
- Future implementation of additional gate with corresponding automation
- Easier access for empty container returns to the terminal for evacuation
- Improving Service + Improving Enforcement = Changing Customer Behaviour

2019 EFFICIENCY IMPROVEMENTS





Manifesto was signed March 15 by several government agencies, port operators, and shipping lines in an effort to ease high utilization in the ports. Effectively, customs-cleared containers that have stayed at the ports for more than 30 days can be transferred to designated inland container depots.



- Continuous investment in human capital and upgrade of infrastructure and superstructure to meet the growing demands of the industry
 - Enables shipping lines to cascade the big ships and operate at a lower cost base in the region
 - Promotes quicker turnaround of vessels contributing to schedule reliability, bunker savings, and shorter truck dwell times
 - More emphasis on complex customer demands (Outside-In/Beyond-the-Gates Approach)





- Expansion of stacking areas to increase capacity
- Building of ECDs to combat perennial empty container return issues
- Commitment to develop more operational efficiencies and automation for the terminal and the industry








- Inter-terminal transfers between International and Domestic terminals are now possible through partial acquisition of MNHPI

- Total logistics cost for cargo bound to Visayas and Mindanao have the potential to be significantly reduced
